The current contract for license examination services was entered into via RFP between the Nebraska Real Estate Commission and Applied Measurement Professionals ("AMP") for the period July 1, 2015, through June 30, 2017, with options to renew for 3 additional two year periods. This agenda item relates to the consideration for approval of the second renewal period, July 1, 2019 to June 30, 2021.

Since the contract was issued, AMP was acquired by PSI Services, LLC ("PSI"), who assumed the responsibility of administering all AMP contracts for such services.

PSI has proposed a renewal with no changes to the terms of the original contract.

The proposed for examinations is \$72 per sales exam and \$82 per broker's exam, like all other terms of the contract it would remain unchanged.
